INTRODUCTION

Purpose and Scope of this Document

The Congress, in recognition of the need for coordination within this community, directed the Environmental Protection Agency to undertake a program to coordinate Federal noise programs pursuant to Section 4 of the Noise Control Act of 1972 (PL92-574). Since effective coordination requires good communication, the EPA has prepared this directory for use as a tool to that end. This document is intended for use by the members of the Federal Noise Abatement and Research Community in identifying and contacting each other.

The first edition of this Directory includes information on persons with disciplines in noise control engineering, health effects science, hearing conservation, law, land use planning, and noise abatement policy making. Federal personnel involved in activities relating to other noise research and control will be considered for inclusion in future editions of this document.

How This Document Was Compiled

Sources for this directory included available noise contact lists as well as published personnel directories. The following DoD directories were particularly helpful:

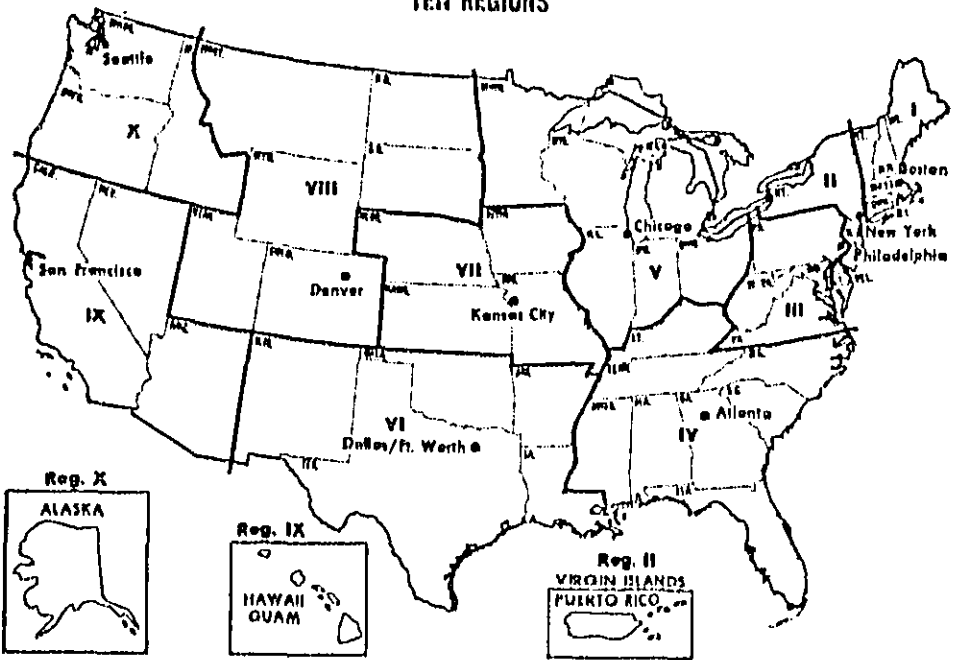
